CHADRON, NEBRASKA June 27, 2023 DAWES COUNTY BOARD OF COMMISSIONERS

The Public convened meeting of the Dawes County Commissioners in regular session commenced at the hour of 9:00 A.M. on the 27th day of June, 2023 pursuant to public notice as required by law. The meeting was called to order by Chairman Webb Johnson. Board Members present were Vic Rivera and Jake Stewart. Also present was Cheryl Feist, Dawes County Clerk, Wade Yada, Highway Superintendent and Kay Hill, Human Resources Director. The Pledge of Allegiance was recited by those present. Per LB 898, Commissioner Johnson announced the location of the Open Meetings Act located on the door by the United States Flag. Copies of the Act are available upon request. Commissioner Stewart, seconded by Commissioner Rivera, moved to approve the agenda. Roll call vote, Ayes: Stewart, Johnson and Rivera. Nays: None. Motion carried. Motion by Commissioner Rivera, seconded by Stewart, to approve the minutes of the June 13, 2023 meeting with the following correction to wit: the meeting was adjourned at 4:00 P.M. as members of the Board attended a CRAKE training. Roll call vote, Ayes: Johnson, Rivera and Stewart. Nays: None. Motion carried. Correspondence acknowledged by the Board was an invitation from Rural Prosperity Nebraska. Monthly fee/mileage reports of the various departments were reviewed and approved by general consent of the Board. Claims were reviewed. Motion by Commissioner Stewart, seconded by Rivera, to approve all claims as presented with the exception of claim #23060350 payable to River A Holdings in the total amount of \$3418.18. Roll call vote, Ayes: Rivera, Stewart and Johnson, Nays: None. Motion carried. Commissioner Stewart, seconded by Johnson, moved to approve claim #23060350 payable to River A Holdings in the total amount of \$3418.18 Roll call vote, Ayes: Stewart and Johnson with Rivera abstaining from the vote. Nays: None. Motion carried. There being no one from the Public for Public Comment, Board reports ensued to wit: Rivera: Region 1 Mental Health met; re-worded policies and discussed staff working from home. Mr. Rivera contacted the State and they aren't working from home. Mr. Rivera requested the Deputy County Attorney draft a letter to be reviewed Region 1 Mental Health's next meeting to be held on August 10, 2023; Panhandle Public Health will meet on June 29, 2023. Stewart: NCAP met, there are several job opportunities available through NCAP in Chadron, Gordon, Alliance and Valentine, Nebraska. NCAP now has a full Board with three new members; NNDC and Region 23 didn't meet. SWANN is asking that the public be reminded to trim back trees, etc. on their person property. The City of Chadron offers Dial-A-Truck at no cost to individuals needing to haul away debris. Johnson: Scottsbluff meetings were cancelled due to the County Board workshop held in Kearney, Nebraska. Commissioner Johnson reported the Board of Equalization workshop had two (2) TERC (Tax Equalization Review Commission) members present; Wayne Bena, Nebraska Secretary of State met with Commissioners present at the workshop; Omaha Port Authority spoke at the conference; there was presentations also by Zelle and Jail Standards. He also reported the Nebraska Department of Roads has money to loan out for road projects.

At 9:30 A.M. Wade Yada, Highway Superintendent, met with the Board. Road Updates include all Districts are grading and fixing washouts due to recent rains. District 1 is still on East Dakota Junction Road and Ferguson Road is still being worked on by Crews. The Game & Parks gravel pit agreement is being pursued by the Road Superintendent. Pete Emerson is pushing at Bolek's pit. In other business the Board reviewed two (2) surplus requests to wit: Assessor -old phone system and Communications disposed of a broken shredder. The Board recessed at 9:50 A.M. and reconvened to regular session at 9:57 A.M. Commissioner Stewart, seconded by Rivera, moved to approve the surplus requests of the Assessor and Communications Department directing the Chairman to sign and the phone system will be offered to any department needing it. Roll call vote, Ayes: Johnson, Rivera and Stewart. Nays: None. Motion carried.

At 10:10 A.M. Lindy Coleman, Assessor, presented an amendment to terminate the previous contract with Pictometry so the new contract can begin. Commissioner Stewart, seconded by Rivera, moved to approve the amendment and direct the Chairman to sign such. Roll call vote, Ayes: Rivera, Stewart and Johnson. Nays: None. Motion carried. The next order of business was adoption of the following resolutions to wit: Resolution No. 2023-17 was introduced by Commissioner Stewart, seconded by Rivera, transferring \$1046.10 from Fund 2910 to Fund 2913. Roll call vote, Ayes: Stewart, Johnson and Rivera. Nays: None. Motion carried. Resolution No. 2023-18 was introduced by Commissioner

Rivera, seconded by Stewart, transferring \$42,000.00 from the Dunlap Road Fund to the Inheritance Fund as payback to the Inheritance Fund. Roll call vote, Ayes: Johnson, Rivera and Stewart. Nays: None. Motion carried. Resolution No. 2023-19 was introduced by Commissioner Stewart, seconded by Rivera, transferring \$25,000.00 from Miscellaneous Fund to the Inheritance Fund as partial payback to the Inheritance Fund. Roll call vote, Ayes: Rivera, Stewart and Johnson. Nays: None. Motion carried. Resolution No. 2023-20 was introduced by Commissioner Stewart, seconded by Rivera, granting budget authority in the amount of \$120,185.84 from the General Fund to the following departments to wit: Dawes County Jail in the amount of \$81,710.08; Dawes County Court in the amount of \$13,950.72; Dawes County District Judge in the amount of \$12,422.45; Building and Grounds in the amount of \$3388.07; Alcohol/Drug in the amount of \$8415.12 and Zoning in the amount of \$299.40. Roll call vote, Ayes: Stewart, Johnson and Rivera. Nays: None. Motion carried.

At 10:35 A.M. Kay Hill, HR Director, informed the Board she has restructured the General Assistance program addressing the way funding is handled and deleting the food assistance as the area has several venues that offer free meals. A voucher system will be looked into for funding. Commissioner Stewart, seconded by Rivera, moved to approve changes to the general assistance program and revisions to guidelines. Roll call vote, Ayes: Johnson, Rivera and Stewart. Nays: None. Motion carried. Amy Sapp, PADD, joined the meeting.

At 10:50 A.M. Amy Sapp, PADD, met with the Board. She reported PADD covers eleven (11) counties or eight (8) Districts in the State of Nebraska. Two (2) Economic Development Grants are available for municipalities. A Leadership program is also available and PADD is updating the email list. She also discussed the CDBG (Community Development Block Grant). PADD is currently working on Internet assistance for individuals on Pell Grants. They can receive internet at a reduced cost through PADD. Several brochures were left at the Courthouse and the HR Department will post some of the brochures on the Dawes County website.

There being no further business before the Board the meeting was adjourned at 11:20 A.M. The next meeting of the Dawes County Commissioners will be held on July 11, 2023 beginning at 9:00 A.M. with a Board of Equalization meeting followed by the Commissioner meeting at approximately 9:20 A.M. Both meetings will be held in the Commissioner Room. The agenda will close at noon on July 06, 2023. All Resolutions adopted by the Dawes County Board of Commissioners are available for public inspection during normal business hours of the County Clerk's Office.
