DAWES COUNTY BOARD OF EQUALIZATION

The Public convened meeting of the Dawes County Board of Equalization in regular session was commenced at the hour of 9:00 A.M. on the 10th day of October, 2023 and published pursuant to public notice as required by law and or posted. The meeting was called to order by Chairman Webb Johnson. Roll was called and the following Commissioners were present: Commissioner Rivera and Commissioner Jake Stewart. Also present was Deb Lesmeister, Deputy Dawes County Clerk; Lindy Coleman, Assessor; Wade Yada, Highway Superintendent and Adam Edmund, Deputy County Attorney. The Pledge of Allegiance was recited by those present. Per LB 898 the Chairman announced the location of posted information concerning the Open Meetings Act. The poster can be found on the door next to the United States Flag. Copies of the Act are available upon request by anyone attending the meeting or requesting a copy. Motion by Commissioner Stewart, seconded by Rivera, accepting the agenda. Roll call vote, Ayes: Stewart, Rivera and Johnson. Nays: None. Motion carried. Motion by Commissioner Stewart, seconded by Rivera, to approve the minutes of the September 09, 2023 meeting as recorded. Roll call vote, Ayes: Rivera, Johnson and Stewart. Nays: None. Motion carried. Correspondence acknowledged by the Board was a TERC appeal by Money Express. Lindy Coleman, Assessor, presented tax correction # 5280 for the Boards review and approval. Upon review of said tax correction by the Board a motion was made by Commissioner Stewart, seconded by Rivera, approving tax correction #5280 and directing the Chairman to sign such. Roll call vote, Ayes: Johnson, Stewart and Rivera. Nays: None. Motion carried. Sam Wellnitz entered meeting at 9:03 A.M.

Resolution 2023-27 pertaining to the adoption of 2023/2024 levies was read aloud by Commissioner Stewart. After it was read aloud Commissioner Rivera made a motion to adopt Resolution 2023-27 adopting the 2023/2024 levies. The motion was seconded by Commissioner Johnson. Roll call vote, Ayes: Stewart, Rivera and Johnson. Nays: None. Motion carried. Copies of the 2023/2024 Levies are available to the Public at the County Clerk's Office. Lindy Coleman left the meeting at 9:07 A.M.

There being no further business to be conducted by the Dawes County Board of Equalization, the Chairman adjourned the meeting at 9:08 A.M.
