## DAWES COUNTY BOARD OF COMMISSIONERS

The Public convened meeting of the Dawes County Commissioners in regular session commenced at the hour of 9:13 A.M. on the 9th day of July, 2024 pursuant to public notice as required by law. The meeting was called to order by Chairman Webb Johnson. Board Members present was Jake Stewart and Vic Rivera. Also, present was Cheryl Feist, Dawes County Clerk; Wade Yada, Highway Superintendent and Adam Edmund, Deputy County Attorney. Per LB 898, Commissioner Johnson announced the location of the Open Meetings Act located on the door by the United States Flag. Copies of the Act are available upon request. Commissioner Stewart, seconded by Rivera, moved to approve the agenda. Roll call vote, Ayes: Stewart, Johnson and Rivera. Nayes. None. Motion carried. The minutes of the June 25, 2024 Commissioner meeting were reviewed. Motion by Commissioner Rivera, seconded by Stewart to approve the minutes as published. Roll call vote, Aves: Johnson, Rivera and Stewart. Nays: None. Motion carried. Claims were reviewed. Commissioner Rivera, seconded by Stewart, moved to approve all claims. Roll call vote, Ayes: Rivera, Stewart and Johnson. Nays: None. Motion carried. Correspondence acknowledged by the Board included a newsletter from the Aging Office. Monthly fee/mileage reports of the various departments were approved by general consent of the board.

At 9:30 A.M. Public Comment was opened by the Board Chairman. No one from the public was present. The Board took this opportunity to remind landowners they are responsible for mowing per LB 39-1811.

At 9:40 A.M. Wade Yada, Highway Superintendent, met with the Board. Road Updates ensued to wit: All three districts are grading when weather conditions allow. District 1-still working at top of Table Road. District 2-Grantham project completed. Commissioner Rivera asked where the county was at re: Road No. 50. Deputy County Attorney, Adam Edmund, updated the board re: status of Road No. 50. District 3-crews are still working on Squaw Mound and Bethel Roads. Also discussed was the Roads Department starting work earlier due to heat. The Board gave the ok to start work at 6:00 A.M. for all crew members. Equipment was discussed briefly. In other business the Board discussed budget workshop. The budget workshop will commence following the Commissioner's Meeting on July 23, 2024. The County Clerk was instructed to advertise such. A SWANN amendment was reviewed which would allow the Agency to issue tax exempt financing for the purchase of a baler. Commissioner Rivera, seconded by Stewart, moved to direct the Chairman to sign the SWANN service agreement amendment. Roll call vote, Ayes: Johnson, Rivera and Stewart. Nays: None. Motion carried. Resolution No. 2024-14 was introduced by Commissioner Rivera, seconded by Stewart, approving the execution and delivery of a second amendment to the service agreement between the County of Dawes and the Solid Waste Agency of Northwest Nebraska; authorizing the execution of such second amendment to the service agreement, approving the issuance of bonds and ratifying all actions taken by the county. Roll call vote, Ayes: Rivera, Stewart and Johnson. Nays: None. Motion carried. The Fur Trade Days Committee presented an application for use of the Courtyard for Fur Trade Days activities. Commissioner Stewart, seconded by Rivera, moved to approve the application for use of the Courtyard July 11-13, 2024. Roll call vote, Ayes: Stewart, Johnson and Rivera. Navs: None. Motion carried.

At 10:00 A.M. Jasmine Spencer-Benson, Safety Committee secretary, met with the board. She indicated NIRMA has grant money available for safety equipment. Communications has reached out to Jasmine and requested NIRMA funding. November 01, 2024 is the deadline to apply for grant money through NIRMA. The Roads Department will run their annual grant request with this years grant. Jasmine will reach out to departments. The Board recessed at 10:05 A.M. and reconvened to regular session at 10:10 A.M.

At 10:10 A.M. Robert Jordan, VSO, met with the Board. He presented the board with a request to appoint Ben Bennett to the Veterans Service Board. Commissioner Stewart, seconded by Rivera, moved to appoint Ben Bennett to the Veteran's Service Board. Roll call vote, Ayes: Johnson, Rivera and Stewart. Nays: None. Motion carried. There being no further business before the Board the meeting was adjourned at 10:15 A.M.The next meeting of the Dawes County Commissioners will be held on July 23, 2024 beginning at 9:00 A.M..
