## CHADRON, NEBRASKA December 23, 2024 DAWES COUNTY BOARD OF COMMISSIONERS

The Public convened meeting of the Dawes County Commissioners in regular session commenced at the hour of 9:00 A.M. on the 23rd day of December, 2024 pursuant to public notice as required by law. The meeting was called to order by Chairman Webb Johnson. Board Members present were Vic Rivera and Jake Stewart. Also, present was Cheryl Feist, Dawes County Clerk; Wade Yada, Highway Superintendent and Terry Curtiss. Per LB 898, Commissioner Johnson announced the location of the Open Meetings Act located on the door by the United States Flag. Copies of the Act are available upon request. The Pledge of Allegiance was recited by those present. Commissioner Stewart, seconded by Rivera, moved to approve the agenda after removal of Airport board appointments. Roll call vote, Ayes: Stewart, Johnson and Rivera. Nays: None. Motion carried. Minutes of the December 10, 2024 Commissioner Meeting were reviewed. Commissioner Rivera, seconded by Stewart, moved to approve the minutes as published with the following corrections to wit: instead of has no ingress/egress as recorded, should read is unsure of ingress/egress off the property, not main road. The word graders instead of dozers as recorded and remove in addition, Mr. Mai has indicated he wants Road No. 50 widened when obstruction is removed. Roll call vote, Ayes: Johnson, Rivera and Stewart. Nays: None. Motion carried. There wasn't any correspondence for Board review. Claims were reviewed. Commissioner Stewart, seconded by Johnson, moved to approve claim#24120196 in the amount of \$792.89 payable to River A Holdings. Roll call vote, Ayes: Stewart and Johnson with Rivera abstaining from the vote. Nays: None. Motion carried. Commissioner Rivera, seconded by Stewart, moved to approve all remaining claims as presented. Roll call vote, Ayes: Rivera, Stewart and Johnson. Nays: None. Motion carried. Monthly fee/mileage reports of the various departments were reviewed and approved by general consent of the Board. No one chose to speak during Public Comment. Board reports ensued to wit: Rivera: No boards met. Stewart: NCAP will re-organize in January of 2025; Region 23 did not meet; NNDC will conduct the Executive Director evaluation and the Dawes County Safety Committee met with nothing to present to the Board. A vehicle accident was reviewed. Johnson: No boards met other than PADD doing a zoom meeting.

At 9:25 A.M. Wade Yada, Highway Superintendent, met with the Board. He informed those present all departments are grading roads and doing equipment maintenance. Pete is almost done with reclaiming the Stumph pit and signage work is on-going. The Board recessed at 9:30 A.M. and reconvened to regular session at 9:33 A.M.

At 9:34 A.M. Brad Streeks, Custodian, presented a bid from Danielson Construction in the amount of \$5250.00 to build a countertop in the Jail facility. Commissioner Stewart, seconded by Rivera, move to approve the bid and direct Mr. Streeks to schedule repairs. Roll call vote, Ayes: Stewart, Johnson and Rivera. Nays: None. Motion carried.

At 9:36 A.M. Del Fuhrman met with the Board re: Manley Road access. The North half of Manley Road is closed. Access was discussed at length. Commissioner Stewart directed the Highway Superintendent to obtain information relevant to Manley Road and report back to the Board.

At 10:15 A.M. Mike Lecher met with the Board re: Road No. 50. Also present was Jim Stolldorf, Clifford Steihl, and Ben Schuckman. He reported he; his wife and Cactus Shumway were sued by John Mai. District Court granted a summary judgement, Appellate Court ruled in favor of the Lechers and the Supreme Court of Nebraska refused to hear the case. Mr. Lecher referenced several cases to wit: Court Order CI 16-76 which addressed the road location. The Court found that County Road 50 is an open road located on the common section lines of Sections 11 and 12 in Township 32 North, Range 49 West of the 6<sup>th</sup> P.M. The right of way

extends 33 feet west into Section 11 and 33 feet east into Section 12. Dawes County received a permanent injunction. Paying a fine is not good enough. The obstruction must be removed. There is nothing in the Court Order to allow the Plaintiff any negotiation. Nebraska Court of Appeals held that the County right of way extends 33 feet on each side of the section line and the physical road, while crossing between Section 11 and Section 12 was within the 66-foot right of way for its entire length. The permanent injunction to remove his sign and all other obstructions from the Right of Way. Courts have ruled according to Lecher, Plaintiff is ordered to remove signs and obstructions in the Right of Way. The County isn't responsible for the removal of such. Mr. Lecher went on to say that on January 09, 2024 LaMoyne Schultz, Department of Transportation also suggested and said all obstructions must be removed within the County Right of Way. Section line was set by the Courts. Terry Curtiss, Atty, indicated Courts can't do that. John Mai then hired Accustar to conduct a survey and locate the original corner marker and billed Dawes County. Dawes County paid the bill and Case No CI 22-11 was filed by the Lechers. The Court ruled in favor of Dawes County and the NOMA portion of the appeal was dismissed. In Court Case CI 16-76 the evidence clearly establishes that Road No. 50 was properly established and used by the public from the late 1800's through 2016. The road was never abandoned by Dawes County. Evidence also establishes that Mr. Mai made significant and costly improvements on the road and all his claims are dependent upon a finding that County Road 50 was not an open public road prior to his purchase of the property in 1999. The Court of Appeals noted that at time of 1887 petition of Road No. 50 all public roads shall have a width of sixty-six feet and the staked line marking such road shall be on the western edge, if the course of the road is north and south. Additionally, all surveys, road records, etc. were recorded. Mr. Lecher asked does a special permit allow obstructions in the County Right of Way? Commissioner Rivera asked why any county would want to permit a safety hazard when DOT also indicated it's a safety hazard. Mr. Rivera asked Mr. Curtiss why Mr. Mai wants to keep the obstruction. Mr. Curtiss indicated the obstruction is part of the road way and Mr. Mai was never told he needed an easement. All one structure according to Curtiss and Surveyor Morrison moved the section line according to Curtiss. Mr. Curtiss indicated the Board has jurisdiction of roads. There is also a federal rule that governs surveys. Mr. Rivera indicated there is a culvert installed for drainage and Clifford Stiehl confirmed there is a culvert. According to Rivera there isn't a drainage issue as previously thought. Mr. Shumway contacted Mr. Rivera and informed him there is a purchase agreement in place. Commissioner's Johnson and Stewart indicated the obstruction removal is up to Commissioner Rivera because its in his Road District. Mr. Curtiss indicated if the obstruction has to be removed that Mr. Mai would prefer to do it himself so he can keep the parts and reuse them. Commissioner Rivera asked Mr. Curtiss to find out if Mr. Mai would rather remove it. Mr. Curtiss indicated he would visit with Mr. Mai and let him know. Copies of all court rulings are attached to these minutes and are available for viewing during normal business hours at the Clerk's Office.

There being no further business before the Board the meeting was adjourned at 11:15 A.M. The next meeting of the Dawes County Commissioners will be held on January 14, 2025 beginning at 9:00 A.M. with the Board of Equalization, followed by the Commissioner meeting at approximately 9:20 A.M. Both meetings will be held in the Commissioner Room. The agenda will close at noon on January 09, 2025. All Resolutions adopted by the Dawes County Board of Commissioners are available for public inspection during normal business hours of the County Clerk's Office.
