DAWES COUNTY BOARD OF COMMISSIONERS

The Public convened meeting of the Dawes County Commissioners in regular session commenced at the hour of 9:02 A.M. on the 23rd day of July, 2024 pursuant to public notice as required by law. The meeting was called to order by Chairman Webb Johnson. Board Members present was Jake Stewart and Vic Rivera. Also, present was Cheryl Feist, Dawes County Clerk and Adam Edmund, Deputy County Attorney, The Pledge of Allegiance was recited by those present, Per LB 898, Commissioner Johnson announced the location of the Open Meetings Act located on the door by the United States Flag. Copies of the Act are available upon request. Commissioner Stewart, seconded by Rivera, moved to approve the agenda noting the addition of a job description for the Predator Control position with 24-hour notice. Roll call vote, Ayes: Stewart, Johnson and Rivera. Nayes. None. Motion carried. The minutes of the July 09, 2024 Commissioner meeting were reviewed. Motion by Commissioner Rivera, seconded by Stewart to approve the minutes as published. Roll call vote, Ayes: Johnson, Rivera and Stewart. Nays: None. Motion carried. Claims were reviewed. Commissioner Stewart, seconded by Rivera, moved to approve all claims with the exception of claim #24070202 payable to River A Holdings in the total amount of \$320.95. Roll call vote, Ayes; Rivera, Stewart and Johnson. Nays: None. Motion carried. Commissioner Stewart, seconded by Johnson, moved to approve claim #24070202 payable to River A Holdings in the total amount of \$320.95. Roll call vote, Ayes: Stewart and Johnson with Rivera abstaining from the vote. Correspondence acknowledged by the Board included a newsletter from NCAP and notice of update to the Hazard Mitigation Plan. Monthly fee/mileage reports of the various departments were approved by general consent of the board.

At 9:30 A.M. Public Comment was opened by the Board Chairman. No one from the public was present. The Board ensued with Board reports to wit: Rivera-SWANN met July 11, 2024. Budgets were reviewed, insurance was renewed through LARM at five percent (5%) discount. Resolution No. 2024-05 was adopted removing assessments, the rest of the meeting was business as usual. Stewart-NCAP met, RFPs were sent out regarding new structure for the Alliance HeadStart program. The CEO's annual performance evaluation was conducted. They are gearing up for school to start. NNDC met and went over loans, it was noted that CDBG funds have been spent out and returned to Dawes County. Rob Bila was elected to serve on the NNDC Board. Region 23 met and went over fire/rescue calls conducted in four (4) counties. Johnson-The majority of his boards didn't meet due to property valuation protest hearings. He did receive an email from Bryan Venable, PADD. There wasn't any report from Wade Yada, Highway Superintendent. In other business the Board reviewed the audit engagement letter. Commissioner Stewart, seconded by Rivera, moved to accept the letter of engagement for the 2024 audit at a cost of \$18,000.00. and directing the Chairman to sign such. Roll call vote, Ayes: Johnson, Rivera and Stewart. Nays: None. Motion carried. Two (2) Visitor Promotion Grants were reviewed to wit: Chadron Chamber in the amount of \$316.94 and Crawford Area Fund in the amount of \$838.00. Upon review, Commissioner Stewart, seconded by Rivera, moved to approve both grants as presented. Rol call vote, Ayes: Rivera, Stewart and Johnson. Nays: None. Motion carried. The next order of business was the Predator Control Interlocal Agreement between Dawes and Sioux counties for predator control services. Upon more review and discussion, a motion was made by Commissioner Stewart, seconded by Rivera, to move forward with the Interlocal Agreement between Dawes and Sioux counties, the job description and directing the Chairman to sign such. Roll call vote, Ayes: Stewart, Johnson and Rivera. Nays: None. Motion carried. The Clerk was instructed to have the Roads Secretary publish notice of an opening for Predator Control position. The Board recessed at 9:47 A.M. and reconvened to regular session at 10:05 A.M. The 10:00 A.M. appointment didn't show. Discussion ensued regarding a road name change request. The Board reiterated the fact that the fire department has the current address. As no one appeared to brief the board about the road name change no action was taken by the Board.

At 10:15 A.M. Gregg Mooney, NACO, introduced himself to the Board. He is a benefits committee member. He explained how NACO came up with a sixteen (16) tier premium package which resulted in lower fees for Dawes County this year. He will be taking over the Ogallala office. April Grant joined the meeting. The Board recessed at 10:24 A.M. and reconvened to regular session at 10:26 A.M.

At 10:27 A.M. Chris Dean, April Grant, Sheriff Jeff Johns and Chief Deputy Lee Sayaloune joined the meeting. Discussion ensued regarding Crawford Law Enforcement. Commissioner Rivera indicated he called this discussion because both sides have been lacking on responsibilities relevant to the contract. He suggested the contract be redone. The original contract called for quarterly meetings and to date not one has been held according to Rivera. April Grant indicated for the record that some council members weren't privy to the meeting held with the mayor. She is all for revisiting the Crawford Law Enforcement Agreement. Adam Edmund, Deputy Attorney, indicated this is a beneficial agreement and needs to remain in place. Commissioner Rivera thanked the Sheriff's Department for their presence at the Crawford 4th of July festivities. Commissioner Rivera, seconded by Stewart, moved to enter executive session to discuss personnel at 10:36 A.M. Roll call vote, Ayes: Johnson, Rivera and Stewart. Nays: None. Motion carried. At 11:30 A.M. a motion to reconvene to regular session with no action taken during executive session was made by Commissioner Stewart and seconded by Commissioner Rivera. Roll call vote, Ayes: Rivera, Stewart and Johnson. Nays: None. Motion carried.

There being no further business before the Board the meeting was adjourned at 11:31 A.M. The next meeting of the Dawes County Commissioners will be held on August 13, 2024 beginning at 9:00 A.M. with a Board of Equalization meeting, followed by the Commissioner meeting at approximately 9:20 A.M. Both meetings will be held in the Commissioner Room. The agenda will close at noon on August 08, 2024. All Resolutions adopted by the Dawes County Board of Commissioners are available for public inspection during normal business hours of the County Clerk's Office.
