CHADRON, NEBRASKA October 08, 2024 DAWES COUNTY BOARD OF COMMISSIONERS

The Public convened meeting of the Dawes County Commissioners in regular session commenced at the hour of 9:07 A.M. on the 8th day of October, 2024 pursuant to public notice as required by law. The meeting was called to order by Chairman Webb Johnson. Board Member present was Jake Stewart. Commissioner Johnson, seconded by Stewart, moved to excuse Commissioner Rivera. Roll call vote, Ayes: Johnson and Stewart. Nays: None. Motion carried. Also, present was Cheryl Feist, Dawes County Clerk; Wade Yada, Highway Superintendent; Clifford Stehle, Wally Juhlin, Martina Lemmon and Jack Galt. Per LB 898, Commissioner Johnson announced the location of the Open Meetings Act located on the door by the United States Flag. Copies of the Act are available upon request. Commissioner Johnson, seconded by Stewart, moved to approve the agenda adding with 24 hours' notice CDBG funding and ADA improvements regarding Crawford Fire Hall, Roll call vote, Aves: Stewart and Johnson. Nays: None. Motion carried. The Budget/Final Tax Request minutes of the September 24, 2024 Commissioner meeting were reviewed. Motion by Commissioner Stewart, seconded by Johnson, approving the minutes with the following corrections to wit: the total tax asking for 2024-2025 is \$4,287,009.37 which is different than the 2023-2024 tax asking of \$4,183,048.82 resulting in an increase of \$103,960.55, not 2024-2025 tax asking of \$103,960.55 as recorded. Roll call vote, Ayes: Johnson and Stewart. Nays: None. Motion carried. Minutes of the Commissioner meeting for September 24, 2024 were reviewed. Commissioner Stewart, seconded by Johnson, moved to approve the Commissioner minutes as recorded. Roll call vote, Ayes: Stewart and Johnson. Nays: None. Motion carried. Claims were reviewed. Commissioner Stewart, seconded by Johnson, moved to approve all claims as submitted. Roll call vote, Ayes: Johnson and Stewart, Nays: None, Motion carried, Monthly fee/mileage reports of the various departments were approved by general consent of the board. Correspondences acknowledged by the Board included NCAP/Area Aging newsletters. Public Comment ensued with Wally Juhlin requesting 911 signage for rural homes as its becoming difficult to find some rural homes when a fire is called in. Discussion ensued. Also discussed was road signage. Commissioner Johnson shared the new Predator Control, Casey Bach's phone number to wit: (308)207-5207. Commissioner Johnson also reported signage on the pickup for Predator Control is done, he has been receiving several calls and he has met with Sioux County and obtained a scope for his rifle. Commissioner Johnson also reported he learned at the Panhandle District Meeting that Casper, Wyoming has a home for individuals experiencing mental conditions. Region 1 Mental Health is looking into a similar situation in Nebraska. It was noted at the Panhandle District Meeting that Kimball, NE. has an old hospital that could be used. Opioid funds could help off-set costs associated with bringing this service to Nebraska.

Jack Galt, representative for the Crawford Fire Hall met with the Board. He presented bids received back from bid packets sent out on 9/23/24 to Danielson Construction who bid \$9.38 per square foot for the Crawford Fire Hall ADA project; Fuller Construction who didn't bid; Anderson/Shaw who bid \$10.61 per square foot and Suchor and Sons who bid \$11.05 per square foot. Danielson Construction was selected by the Crawford Fire Hall Board to do the ADA project. He also informed the Board that 1500 square feet of concrete was deleted from the project to save on costs. Commissioner Stewart, seconded by Johnson, moved to accept the Danielson Construction bid at \$9.38 per square foot for the ADA CDBG re-use funding with administrative services being conducted by PADD. Roll call vote, Ayes: Stewart and Johnson. Nays: None. Motion carried. Commissioner Stewart indicated for the record that any entity seeking funds through the CDBG re-use funding are required to go through the bid process for Dawes County to approve funding for the entity.

Wade Yada, Highway Superintendent, met with the Board. Road Updates included the following to wit: District 1 is done graveling on East Table Road and will move onto Davenport and Alpha Roads. District 2 is hauling rock on East River Road and will be working on Dry Creek Road. District 3 is finishing up on Squaw Creek then moving west to Ash Creek Road. The Construction Crew is clearing trees on West Ash Creek Road. Mr. Yada reported he has one (1) opening in District 2. He has received two (2) applications and plans to interview next week. He reported he attended the Bridgeport Panhandle District Meeting and learned there is LTAP funding available. He plans to work with the Box Butte County Highway Superintendent to secure funding for an asphalt project. More cross-training is being

conducted amongst crew members. He reported a JD Motor Grader used during the recent fire is at the John Deere shop to see what caused the steering to go out. Fire reimbursement was also discussed. A petition request submitted by Ronald Scherbarth to install a water line across a road located in Section 31, Township 31, Range 49 was reviewed by the Board and Highway Superintendent. Commissioner Stewart, seconded by Johnson, moved to approve the petition request of Ronald Scherbarth. Roll call vote, Ayes: Johnson and Stewart. Nays: None. Motion carried. The Board recessed at 9:45 A.M. and reconvened to regular session at 9:54 A.M.

At 9:55 A.M. Linda Verhage met with the Board. She requested more signage for the Amish Community. Specifically, Four Mile Corner and Saw Logs Roads need signage. She reported there is another school and both schools need proper signage. Wade Yada indicated for the record that signage is planned for several roads.

At 10:05 A.M. Sam Wellnitz, Treasurer and Deann Koerber, Deputy Treasurer, met with the Board, Mr. Wellnitz presented listings of unsold 2024 taxes, Personal Property listing due to be stricken as they are over fifteen (15) years old and a distress warrant list certified by the Dawes County Treasurer. Upon review and discussion with the Treasurer, Commissioner Stewart, seconded by Johnson, moved to accept the listing of 2024 unsold taxes, Personal Property to be stricken that is over fifteen (15) years old and the distress warrant list certified by the Dawes County Treasurer, Roll call vote, Ayes: Stewart and Johnson. Nays: None. Motion carried. As a note for the record the 2024 unsold tax list is available at the Treasurer's Office. Deann Koerber met with the Board regarding a county burial. Discussion ensued. The possibility of filing a small claim complaint was discussed to recoup some costs associated with the burial. Ms. Koerber also informed the board that a new contract with Chamberlain Chapel might be forth coming. The next order of business was transfer of property from the Weed Department to the Predator Control Department. Commissioner Stewart, seconded by Johnson, moved to remove the 4-wheeler and Trailer from the Weed Department Inventory and put the equipment in the Predator Control Inventory. Roll call vote, Ayes: Johnson and Stewart. Nays: None. Motion carried. Three (3) Tourism Grants were presented for Board approval to wit: Crawford Cattle Call in the amount of \$2000.00; Post Playhouse in the amount of \$30,000.00 and Agricultural Society which was denied by the Tourism Board. Commissioner Stewart, seconded by Johnson, moved to approve the Post Playhouse Improvement grant in the amount of \$30,000.00 and the Crawford Cattle Call promotional grant in the amount of \$2000.00. Roll call vote, Ayes: Stewart and Johnson. Nays: None. Motion carried. No action was taken on the Agricultural Society grant. The last order of business was to set a special Board of Equalization meeting to adopt the 2024-2025 levies for Dawes County. Discussion ensued. Due to the untimeliness of receipt of a budget levies couldn't be adopted at today's meeting but are due to be set by October 20, 2024. The Board won't meet again until October 22, 2024. The special meeting notice will be posted and will take place on October 15, 2024 commencing at 10:00 A.M. in the Commissioners room. The meeting is open to the public.

There being no further business before the Board the meeting was adjourned at 10:50 A.M. The next meeting of the Dawes County Commissioners will be held on October 22, 2024 beginning at 9:00 A.M. The meeting will be held in the Commissioner Room. The agenda will close at noon on October 17, 2024. All Resolutions adopted by the Dawes County Board of Commissioners are available for public inspection during normal business hours of the County Clerk's Office.
