## CHADRON, NEBRASKA October 28, 2025 DAWES COUNTY BOARD OF COMMISSIONERS

The Public convened meeting of the Dawes County Commissioners in regular session commenced at the hour of 9:08 A.M. on the 10<sup>th</sup> day of November, 2025 pursuant to public notice as required by law. Notice of said meeting was posted on the Dawes County website and published in the Crawford Clipper Newspaper. The meeting was called to order by Chairman Vic Rivera. Board Members present were Walter Juhlin and Jake Stewart. Also present was Cheryl Feist, Dawes County Clerk; Wade Yada, Highway Superintendent; Adam Edmund, Deputy County Attorney. Per LB 898, Commissioner Stewart announced the location of the Open Meetings Act located on the door by the United States Flag. Copies of the Act are available upon request. Commissioner Stewart, seconded by Juhlin, moved to approve the agenda. Roll call vote, Ayes: Juhlin, Stewart and Rivera. Nays: None. Motion carried. Minutes of the October 28, 2025 Commissioner Meeting were reviewed. Commissioner Juhlin, seconded by Stewart, moved to approve the minutes as published. Roll call vote, Ayes: Stewart, Rivera and Juhlin. Nays: None. Motion carried. Sam Wellnitz, Treasurer, joined the meeting. Monthly fee/mileage reports of the various departments were approved by general consent of the Board. Claims were reviewed. Commissioner Juhlin, seconded by Stewart, moved to approve all claims as submitted. Roll call vote, Ayes: Rivera, Juhlin and Stewart. Nays: None. Motion carried. There being no correspondence, Public Comment ensued with Commissioner Stewart informing those present that Regina Ochoa appreciates the work done on Bethel Road along with the bridge work done East of Bethel Church. This information will be shared with Road Crew Members.

At 9:03 A.M. Wade Yada, Highway Superintendent, met with the Board. Also present was Lindy Coleman, Assessor. Ms. Coleman reported there is an issue with a road name. Maps show two (2) names, its only one (1) name and its spelled incorrectly. The current owner has requested a 911 address to include proper spelling of the road name. The Board instructed the Highway Superintendent to correct signage and spelling of road name. Road Updates ensued to wit: District 1-grading roads, helping haul gravel in District 3. Terry Serres has moved to District 1. District 2-culvert installed on Table Road with old culvert going on surplus. Hauling gravel to Nixon Road. Will be working on Dry Creek Road. Robbie Diehl is working in District 2 now. District 3-working on Squaw Mound Road. Pete is working on replacing culverts and autogates. Crack sealing is done on Airport, Country Club and Redfern roads. Dunlap and Table Center roads also had some crack sealing done. Bridge inspections are almost completed as well according to Yada. In other business the Board reviewed two (2) surplus requests to wit: Clerk wants to surplus a computer and the Assessor is also requesting surplus of a computer. Both are obsolete and will be disposed of. Commissioner Juhlin, seconded by Stewart, moved to surplus both computers. Roll call vote, Ayes: Juhlin, Stewart and Rivera. Nays: None. Motion carried. Sam Wellnitz, Treasurer joined the meeting. He reported there has been a coding error with the 2910-2913 funds. Commissioner Stewart, seconded by Juhlin, moved to direct the Treasurer to correct the coding error. Roll call vote, Ayes: Stewart, Rivera and Juhlin. Nays: None. Motion carried. He then presented a brief report on Investments. There is plenty of money in working account. He has some CD's coming duel. Money Market changes are coming. The Money Market from Omaha will be combined with a CD at Platte Valley Bank. Some money will also be moved to the NPAIT account. Commissioner Stewart, seconded by Juhlin, acknowledging investments and movement of money to CD's and NPAIT. Roll call vote, Ayes: Rivera, Juhlin and Stewart. Nays: None. Motion carried. Becky Hutchings with UNL Extension joined the meeting. She shared information relevant to advertising for a 4-H position open and a pamphlet

outlining their strategic direction. Gracie Ortner introduced herself to the Board. She is the new Office Manager for UNL Extension. The Board welcomed her.

There being no further business before the Board the meeting was adjourned at 9:38 A.M. The next meeting of the Dawes County Commissioners will be held on November 25, 2025 beginning at 9:00 A.M. The meeting will be held in the Commissioner Room. The agenda will close at noon on November 20, 2025.
