## CHADRON, NEBRASKA May 14, 2024 DAWES COUNTY BOARD OF COMMISSIONERS

The Public convened meeting of the Dawes County Commissioners in regular session commenced at the hour of 10:10 A.M. on the 14<sup>th</sup> day of May, 2024 pursuant to public notice as required by law. The meeting was called to order by Chairman Webb Johnson. Board Members present was Jake Stewart and Vic Rivera. Also, present was Cheryl Feist, Dawes County Clerk; Wade Yada, Highway Superintendent, and Adam Edmund, Deputy County Attorney. Per LB 898, Commissioner Johnson announced the location of the Open Meetings Act located on the door by the United States Flag. Copies of the Act are available upon request. Commissioner Stewart, seconded by Rivera, moved to approve the agenda as presented. Roll call vote, Ayes: Stewart, Johnson and Rivera. Nays: None. Motion carried. Motion by Rivera, seconded by Stewart to approve the minutes of the April 23, 2024 meeting. Roll call vote, Aves: Johnson, Rivera and Stewart, Nays: None, Motion carried, Claims were reviewed. Motion by Commissioner Stewart, seconded by Rivera to approve all claims with the exception of claim# 24050127 payable to Rivera A Holdings in the amount of \$315.00. Roll call vote, Ayes: Rivera, Stewart and Johnson. Nays: None. Motion carried. Motion by Johnson, seconded by Stewart to approve claim #24050127 payable to River A Holdings in the amount of \$315.00. Roll call vote, Ayes: Stewart and Johnson with Rivera abstaining from the vote. Nays: None. Motion carried. The Board acknowledged receipt of correspondences received from Nebraska Department of Transportation. Monthly fee/mileage reports of the various departments were approved by general consent of the Board. The Board recessed at 10:17 A.M. and reconvened to regular session at 10:21 A.M.

At 10:22 A.M. Mark Klemke, Mobius Communications presented a petition request to install fiber optic lines to the radar site located in Section's 20, 21 Township 30 Range 51 located on East Belmont Road. Commissioner Stewart, seconded by Rivera, moved to approve the petition request of Mobius Communications and directing the Chairman to sign such. Roll call vote, Ayes: Johnson, Rivera and Stewart. Nays: None. Motion carried.

At 10:25 A.M. Ron Moore, The Ridge, approached the Board to request approval of a SDL for the Chadron State Park celebration to be held June 7-8, 2024 at the Chadron State Park. Commissioner Stewart, seconded by Rivera, moved to approve the SDL submitted by The Ridge and directing the Chairman to sign such. Roll call vote, Ayes: Rivera, Stewart and Johnson. Nays: None. Motion carried.

At 10:28 A.M. Brad Streeks, Custodian, presented a bid in the amount of \$7800.00 received from Chadron Glass to replace windows in the Jail Facility. Discussion ensued. Commissioner Stewart, seconded by Rivera, moved to award the bid to Chadron Glass in the amount of \$7800.00. Roll call vote, Ayes: Stewart, Johnson and Rivera. Nays: None. Motion carried.

At 10:30 A.M. Wade Yada, Highway Superintendent, presented Road Updates to wit. All districts are grading roads due to recent moisture. District 1 is hauling onto Egan Road and has started the Airport Road area. District 2 is finishing up on hauling gravel to County Club Road and will go to Table Road west of the highway. District 3 is grading and will start working on Squaw Creek and Crow Butte Roads. Pete has been reclaiming pits, the bridge east of Bethel Church will be torn down and a culvert installed. He also reported the Road #50 letter is in final stages and will be sent out. He reported he has one dozer that will need some repair work and he informed the Board the Nebraska Department of Transportation and the Governor of Nebraska will be at Platte Valley Bank today at 1:30 P.M. He plans to attend. In other business the Board reviewed a surplus request from the Public Defenders Office. Commissioner Rivera, seconded by Stewart, moved to surplus the Dell computer and discard of the computer as it no longer works. Roll call vote, Ayes: Johnson, Rivera and Stewart. Nays: None. Motion carried. The Board then reviewed the Blue Cross Blue Shield subgroup renewal. Discussion ensued. Commissioner Stewart indicated with the drop in health rates, they are being very competitive with other Vendors such as Medica, etc. In comparing rates, it was determined to stay with Blue Cross Blue Shield of Nebraska. Commissioner Stewart, seconded by Rivera, moved to stay with the \$1600.00 deductible for health insurance and offer the same dental plan again. Roll call vote, Ayes: Rivera, Stewart and Johnson. Nays: None. Motion carried. The County will pay 90% of the premium costs associated with health care. Three Tourism grants were reviewed to wit: Old West Rodeo in the amount of \$4500.00; Western Art Show in the amount of \$5,000.00 and Crawford Chamber in the amount of \$2,000.00. Commissioner Stewart,

seconded by Rivera, moved to approve all three (3) grants in the amounts requested. Roll call vote, Ayes: Stewart, Johnson and Rivera. Nays: None. Motion carried.

At 10:55 A.M. Sam Wellnitz, Treasurer, approached the Board and requested permission to do a Journal Entry from 2910 Fund to the 2913 Fund to correct a clerical error. Commissioner Stewart, seconded by Rivera, moved to direct the Treasurer to do a Journal Entry re: error in dispersing funds between 2910/2913 Funds. Roll call vote, Ayes: Johnson, Rivera and Stewart. Nays: None. Motion carried.

There being no further business before the Board the meeting was adjourned at 11:03 A.M. The next meeting of the Dawes County Commissioners will be held on April 28, 2024 beginning at 9:00 A.M. The meeting will be held in the Commissioner Room. The agenda will close at noon on April 23, 2024. All Resolutions adopted by the Dawes County Board of Commissioners are available for public inspection during normal business hours of the County Clerk's Office.
