The Public convened meeting of the Dawes County Board of Equalization in regular session was commenced at the hour of 9:00 A.M. on the 9th day of December, 2025 and published in the Crawford Clipper and posted on the County website pursuant to public notice as required by law and or posted. The meeting was called to order by Chairman, Vic Rivera. Board Members present were Jake Stewart and Walt Juhlin. Also present was Cheryl Feist, Dawes County Clerk; Wade Yada, Highway Superintendent; Adam Edmund, Deputy County Attorney; Sam Wellnitz, Treasurer and Nelson Stephens. The Pledge of Allegiance was recited by those present. Per LB 898 the Chairman announced the location of posted information concerning the Open Meetings Act. The poster can be found on the door next to the United States Flag. Copies of the Act are available upon request by anyone attending the meeting or requesting a copy. Motion by Commissioner Stewart, seconded by Juhlin, accepting the agenda. Roll call vote, Ayes: Juhlin, Stewart and Rivera. Nays: None. Motion carried. Motion by Commissioner Juhlin, seconded by Stewart, to approve the minutes of the 11/10, 2025 Board of Equalization Meeting as published. Roll call vote, Ayes: Stewart, Rivera and Juhlin. Nays: None. Motion carried. There being no tax corrections the County Treasurer presented vehicle exemption renewals for Chadron Hospital (see attached list) and Camp Norwesca on a 2008 Ford Sport Van, 2015 Dodge SUV, 2005 Ford Pickup and a flatbed trailer. Upon review of said vehicle exemption renewals the following motions were made to wit: Commissioner Stewart, seconded by Juhlin, moved to approve Chadron Hospitals listing of vehicle exemption renewals. Roll call vote, Ayes: Rivera, Juhlin and Stewart. Nays: None. Motion carried. Commissioner Stewart, seconded by Juhlin, moved to Camp Norwesca's vehicle exemption renewals as listed above. Roll call vote, Ayes: Juhlin, Stewart and Rivera. Nays: None. Motion carried.

There being no further business to be conducted by the Dawes County Board of Equalization, the Chairman adjourned the meeting at 9:08 A.M. The next meeting will be held on January 13, 2026 at 9:00 A.M.
