## PRIMARY ELECTION

Because the law requires rotation of the candidates' names, the chronological order as listed may be different in your precinct and because some candidates are nominated in specified districts, names listed in this sample ballot may not appear on the ballot in your precinct. Ballots will be mailed to all eligible Electors on April 24, 2024.

### INSTRUCTIONS TO VOTER

- To vote you must blacken the oval completely. Use a Black Pen to vote.
- To write-in a name, you must blacken the oval to the left of the line provided.
- Do not cross out-if you change your mind, exchange your ballot for a new one.
- Place voted ballot into the return envelope. Write your NE driver's license or state ID in the space provided on the envelope, or enclose a photo copy of an acceptable photo ID.
- Complete, SIGN and seal the envelope. Remember to moisten both seals to cover the voter ID and signature boxes.
- Return Ballot by mailing back in the envelope provided or deposit in ballot box located at the Courthouse.
- Ballot MUST be in possession of the County Clerk's office by 7:00 p.m. MST on May 14, 2024.
