CHADRON, NEBRASKA February 13, 2024 DAWES COUNTY BOARD OF COMMISSIONERS

The Public convened meeting of the Dawes County Commissioners in regular session commenced at the hour of 9:46 A.M. on the 13th day of February, 2024 pursuant to public notice as required by law. The meeting was called to order by Chairman Webb Johnson. Board Members present were Vic Rivera and Jake Stewart. Also, present was Cheryl Feist, Dawes County Clerk; Adam Edmund, Deputy County Attorney, Wade Yada, Highway Superintendent. Per LB 898, Commissioner Johnson announced the location of the Open Meetings Act located on the door by the United States Flag. Copies of the Act are available upon request. Commissioner Stewart, seconded by Rivera, moved to approve the agenda. Roll call vote, Ayes: Stewart, Johnson and Rivera. Nays: None. Motion carried. Commissioner Rivera, seconded by Johnson, moved to approve the minutes of the January 23, 2024 as recorded. Roll call vote, Aves: Johnson and Rivera with Stewart abstaining from the vote, Navs: None, Motion carried. Claims were reviewed. Motion by Commissioner Stewart seconded by Johnson, approving claim#'s 24020079 in the total amount of \$252.00 and #24020131 in the total amount of \$18,806.29 both payable to River A Holdings. Roll call vote, Aves: Stewart and Johnson with Rivera abstaining from the vote. Commissioner Stewart, seconded by Rivera, moved to pay all claims as submitted with the exception of claim#'s 24020079 and 24020131 both payable to River A Holdings. Roll call vote, Ayes: Rivera and Stewart with Johnson abstaining from the vote. Nays: None. Motion carried.

At 10:01 A.M. The Chairman declared the public hearing open regarding the One/Six Year Road Plan. Wade Yada, Highway Superintendent, went over the One/Six Year Road Plan with Board Members. A complete breakdown of the plan is attached to these minutes and are available for public inspection. Dan Wordekemper joined the meeting at 10:15 A.M. There being no one from the Public to comment, provide input, etc. the Chairman declared the public hearing closed at 10:16 A.M. Resolution No. 2024-11 was introduced by Commissioner Rivera, seconded by Stewart adopting the One/Six Year Road Plan and directing the Chairman to sign such. Roll call vote, Ayes: Johnson, Rivera and Stewart noting that Commissioner Stewart approves the entire plan with the exception of Road No. 50 improvements. Nays: None. Motion carried. Road updates indicated that all crews are grading roads. Correspondence received was an Invitation to the Treasure Chest planning. In other business the Board reviewed by general consent the monthly fee/mileage reports of the various departments.

At 10:30 A.M. Tanya Storer, introduced herself as a candidate for the Legislature District 43. She refers to herself as a fiscal/social conservative and was previously a Cherry County Commissioner. She understands the needs of rural Nebraska. Some areas of concern the Board shared with her included changes in the valuation process to benefit the taxpayers; Inheritance tax loss as counties rely upon the Inheritance Fund to operate between tax collection times and use this fund for emergencies; unfunded mandates by the State, namely UNL personnel that Dawes County pays 100% of salary and benefits; revenue loss is another concern of the Board. Ms. Storer indicated she has visited with Senator Erdman regarding the EPIC tax bill. She is concerned how the bill will play out if adopted. In other business the Board made an ARPA reporter appointment. Commissioner Stewart, seconded by Rivera, moved to appoint Jennifer VanVleet as ARPA reporter for Dawes County at a rate of \$20.00 per hour and directing the Chairman to sign a consulting contract with CORE CPA for ARPA. Roll call vote, Ayes: Rivera, Stewart and Johnson. Nays: None. Motion carried.

At 10:40 A.M. Mandy Horn, Tailgate Bar, presented a SDL request for a Post Playhouse fundraiser to be held on March 16, 2024. Upon review of the Board a motion was made by Commissioner Stewart, seconded by Rivera, approving the SDL request and directing the Chairman to sign such. Roll call vote, Ayes: Stewart, Johnson and Rivera. Nays: None. Motion carried. The Board recessed at 10:47 A.M. and reconvened to regular session at 10:56 A.M. The Human Resources Department was discussed. Those present were Gary Bridges, VSO; Katie Schenbeck, Public Defenders Office; Dana Streeks and Celeste Cattin, Clerk of District Court Office; Sam Wellnitz, Treasurer; Bobbi Wellnitz, Administrative Assistant, Sheriff's Department; Lindy Coleman, Assessor; Wade Yada, Highway Superintendent and Dan Wordekemper, Weed Superintendent. After contacting several counties who utilize the ZELLE HR program, the Personnel Policy committee recommended the Board keep HR duties in-house but go with outside counsel for FMLA issues, vacation leave and dispute resolutions. Several different concerns were

brought up to the Board during the discussion. Some of these concerns are the availability of the HR Director in the past, centralized personnel file location, contract with Pamela Bourne; training of Elected Officials in HR related matters etc. Vacation payout was also discussed. It was leaned a letter was received from Douglas, Kelly, Ostdiek, Snyder, Ossian, Vogl and Snyder, PC addressing the vacation policy back in 2019 with another follow-up by the HR Department in 2023 regarding the vacation policy. Individuals present questioned why nothing was followed up on regarding correspondences received relevant to the vacation policy. The Board will need to decide if they are going to keep following the current policy (use it or lose it) or go back and pay out unused vacation once the Deputy County Attorney has an answer on how far back the county will need to go. The Personnel policy will be updated to reflect changes in the vacation policy. The Board will also need to make appointments for ADA Coordinator, Privacy Officer and General Assistance Coordinator. Discussion ensued. Commissioner Stewart will assume the ADA Coordinator duties. The County Clerk indicated for the record she would be interested in Privacy Officer but no action was taken. The Personnel files will come back to the Clerk's Office after the audit is complete. Also discussed was the current audit. Many present expressed concerns with the unprofessional treatment by the Auditors in various departments. Commissioner Stewart asked those with concerns to please write them out and send them to him.

At 11:49 A.M. Rex Cogdill and Sharon Rickenbach, Dawes County Museum, met with the Board. Rex Cogdill introduced himself as the new Director at the Museum. He reported the Museum had 1,581 visitors to the Museum since April of 2023. Many of those visitors came from nine foreign countries. The Museum is open May 1st and closed for the season on September 30th. Some of the events the Museum has hosted are the History in Action Day, Frontier School Days; Garden Party, etc. Everyone is encouraged to visit the Museum and the Board was thanked for their support of the Museum. In other business Commissioner Stewart reported he had contacted AG's Office regarding two Commissioners being at the SWANN Board Meetings. He was told there is no conflict in this situation because its SWANN business being conducted, not County business. He recommended the Board appoint a board representative to the SWANN Board. Commissioner Johnson, seconded by Stewart, moved to appoint Vic Rivera to the SWANN Board. Roll call vote, Ayes: Johnson, Rivera and Stewart. Nays: None. Motion carried. A surplus request for the workroom shredder was reviewed by the Board. Commissioner Stewart, seconded by Rivera, moved to approve the surplus of a shredder, tag#01737 and dispose of the shredder as it no longer works. Roll call vote, Ayes: Rivera, Stewart and Johnson. Nays: None. Motion carried.

There being no further business before the Board the meeting was adjourned at 12:10 P.M. The next meeting of the Dawes County Commissioners will be held on February 27, 2024 beginning at approximately 9:00 A.M. The meeting will be held in the Commissioner Room. The agenda will close at noon on February 22, 2024. All Resolutions adopted by the Dawes County Board of Commissioners are available for public inspection during normal business hours of the County Clerk's Office.
