The Public convened meeting of the Dawes County Board of Equalization in regular session was commenced at the hour of 9:02 A.M. on the 13th day of August, 2024 and published pursuant to public notice as required by law and or posted. The meeting was called to order by Chairman Webb Johnson. Roll was called and the following Commissioners were present: Commissioner Rivera; Commissioner Stewart, Cheryl Feist, Dawes County Clerk; Adam Edmund, Deputy County Attorney; Wade Yada, Highway Superintendent; Craig Raymer and Sam Wellnitz, Treasurer. The Pledge of Allegiance was recited by those present. Per LB 898 the Chairman announced the location of posted information concerning the Open Meetings Act. The poster can be found on the door next to the United States Flag. Copies of the Act are available upon request by anyone attending the meeting or requesting a copy. Motion by Commissioner Stewart, seconded by Rivera, accepting the agenda. Roll call vote, Ayes: Stewart, Johnson and Rivera. Nays: None. Motion carried. Motion by Commissioner Stewart, seconded by Rivera, to approve the minutes of the July 09, 2024 Board of Equalization Meeting. Roll call vote, Ayes: Johnson, Rivera and Stewart. Nays: None. Motion carried. Commissioner Rivera, seconded by Stewart, moved to approve minutes of July 15, 2024 valuation protest hearings. Roll call vote, Ayes: Rivera, Stewart and Johnson. Nays: None. Motion carried. Dawn Sayaloune, Deputy Assessor presented tax correction # 5361 for the Boards review and approval. Upon review, Commissioner Stewart, seconded by Rivera, moved to approve tax correction # 5361 and directed the Chairman to sign such. Roll call vote, Ayes: Stewart. Johnson and Rivera. Nays: None. Motion carried.

At 9:08 A.M. Sam Wellnitz, Treasurer, presented a vehicle exemption renewal for Crawford Lutheran Church. Upon review of said application renewal, Commissioner Stewart, seconded by Rivera, moved to approve the vehicle exemption renewal for Crawford Lutheran Church and directed the Chairman to sign such. Roll call vote, Ayes: Johnson, Rivera and Stewart. Nays: None. Motion carried.
