CHADRON, NEBRASKA October 14, 2025 DAWES COUNTY BOARD OF COMMISSIONERS

The Public convened meeting of the Dawes County Commissioners in regular session commenced at the hour of 9:07 A.M. on the 14th day of October, 2025 pursuant to public notice as required by law. The meeting was called to order by Vice Chairman Jake Stewart. Board Member present was Walter Juhlin. Commissioner Rivera was excused. Also present was Cheryl Feist, Dawes County Clerk; Wade Yada, Highway Superintendent and Adam Edmund, Deputy County Attorney. Per LB 898, Commissioner Stewart announced the location of the Open Meetings Act located on the door by the United States Flag. Copies of the Act are available upon request. Commissioner Juhlin, seconded by Stewart, moved to approve the agenda. Roll call vote, Ayes: Stewart and Juhlin. Nays: None. Motion carried. Minutes of the September 23, 2025 Commissioner Meeting were reviewed. Commissioner Juhlin, seconded by Stewart, moved to approve the minutes as published. Roll call vote, Ayes: Juhlin and Stewart. Nays: None. Motion carried. Monthly fee/mileage reports of the various departments were approved by general consent of the Board. Claims were reviewed. Commissioner Juhlin, seconded by Stewart, moved to approve all claims as submitted. Roll call vote, Ayes: Stewart and Juhlin. Nays: None. Motion carried. No Correspondence was received. Public Comment ensued with Clifford Wineteer expressing concern over erosion damage to the ledge of a sidewalk at the Fairgrounds. He believes this is a safety issue and needs addressed. He is very appreciative of the individuals who assisted his wife during the incident.

At 9:20 A.M. Wade Yada, Highway Superintendent, presented road updates to wit: District 1 is done on McHenry Road then will move onto Beaver Valley. District 2 is graveling Table and Nixon Roads. District 3 is graveling on Lemmon Road. The Crusher is up and running at the Goff pit. Discussion ensued regarding the early return of the rented crusher. All Districts are grading roads.201.7 miles of road have been bladed to date. In other business he presented a petition request for Alan Soester to trench a pipeline across Mill Road located in 34-32-52 and 27-32-52 for a well. Commissioner Juhlin, seconded by Stewart, moved to approve the petition request and directing the Highway Superintendent to monitor the situation. Roll call vote, Ayes: Juhlin and Stewart. Nays: None. Motion carried.

At 9:35 A.M. Kerri Rempp, Tourism Director, met with the Board. She presented the following grants for the Boards review and approval to wit: Post Playhouse improvement grant in the amount of \$25,000.00 to be used towards housing Actors; Chadron Rotary and Crawford Serving Humanities both in the amount of \$2,000.00 each. These two grants are incentive grants which are capped at \$2000.00 but the entity can return for advertising revenue according to Rempp. Other counties are actively issuing incentive grants as well; Chadron Festival of Quilts in the amount of \$980.00 and Crawford Cattle Call in the amount of \$1,000.00. Discussion ensued regarding the various grants. Commissioner Juhlin, seconded by Stewart, moved to approve all grants in their requested amounts. Roll call vote, Ayes: Stewart and Juhlin. Nays: None. Motion carried. A letter to the Nebraska Department of Revenue requesting a listing of lodging tax permit holders was shared with the Board. Commissioner Stewart, seconded by Juhlin, moved to direct the Vice Chairman to sign the letter. Roll call vote, Ayes: Juhlin and Stewart. Nays: None. Motion carried. The approval to use Improvement fund proceeds for Visitor Promotion was also discussed. Commissioner Juhlin, seconded by Stewart, moved to approve the use of Improvement fund proceeds for Visitor Promotion grants. Roll call vote, Ayes: Stewart and Juhlin. Nays: None. Motion carried.

At 10:00 A.M. Sam Wellnitz, Treasurer, met with the Board re: ARPA funds. He reported the Federal Government shows Dawes County didn't expend \$5989.08 of the ARPA

funds allocated to Dawes County. Mr. Wellnitz indicated his line item shows a balance of \$172.00 not spent. He turned in a claim to the line item to balance. According to the ARPA reported there was a duplicate entry made which could be the difference in the amounts the Treasurer and ARPA reporter show. Mr. Wellnitz will continue to work with the ARPA reporter to balance out the ARPA funds. He will report back to the Board at the November 10, 2025 Commissioner meeting. In other business, Theresa Haynes has expressed an interest in being a Zoning Board Member in District 2. The Board received a copy of her letter prior to the meeting. Commissioner Juhlin, seconded by Stewart, moved to appoint Theresa Haynes to the Zoning Board representing District 2. She replaces Rosalene Tollman who retired from the board. Roll call vote, Ayes: Juhlin and Stewart. Nays: None. Motion carried. Resolution No. 2025-26 was introduced by Commissioner Juhlin, seconded by Stewart, appointing Casey Keim interim County Clerk effective December 31, 2025. Roll call vote, Ayes: Stewart and Juhlin. Nays: None. Motion carried. Resolution No. 2025-27 was introduced by Commissioner Juhlin, seconded by Stewart, transferring \$200,000.00 from the General Fund 0100 to the Roads Fund 0200 to meet expenditures of the Road Fund. Roll call vote, Ayes: Juhlin and Stewart. Nays: None. Motion carried.

There being no further business before the Board the meeting was adjourned at 10:12 A.M. The next meeting of the Dawes County Commissioners will be held on October 28, 2025 beginning at 9:00 A.M. with the Commissioner meeting. The meeting will be held in the Commissioner Room. The agenda will close at noon on October 23, 2025. All Resolutions adopted by the Dawes County Board of Commissioners are available for public inspection during normal business hours of the County Clerk's Office.
