The Public convened meeting of the Dawes County Board of Equalization in regular session was commenced at the hour of 9:00 A.M. on the 14th day of October, 2025 and published pursuant to public notice as required by law and or posted. The meeting was called to order by Vice Chairman Jake Stewart. Roll was called and the following Commissioner was present, Commissioner Juhlin. Commissioner Rivera was excused. Also present was Adam Edmund, Deputy County Attorney; Sam Wellnitz, Treasurer; Wade Yada, Highway Superintendent and Cheryl Feist, Dawes County Clerk. The Pledge of Allegiance was recited by those present. Per LB 898 the Chairman announced the location of posted information concerning the Open Meetings Act. The poster can be found on the door next to the United States Flag. Copies of the Act are available upon request by anyone attending the meeting or requesting a copy. Motion by Commissioner Juhlin, seconded by Stewart, accepting the agenda. Roll call vote, Ayes: Stewart and Juhlin. Nays: None. Motion carried. Motion by Commissioner Juhlin, seconded by Stewart, to approve the minutes of the August 12, 2025 Board of Equalization Meeting as published. Roll call vote, Ayes: Juhlin and Stewart Nays: None. Motion carried. There was no Board of Equalization for the month of September 2025. Sam Wellnitz, Treasurer, presented a vehicle exemption renewal for Bethlehem Lutheran Church on a 2016 Toyota. Commissioner Juhlin, seconded by Stewart, moved to approve the exemption status of Bethlehem Lutheran Church. Roll call vote, Ayes: Stewart and Juhlin. Nays: None. Motion carried.

There being no further business to be conducted by the Dawes County Board of Equalization, the Chairman adjourned the meeting at 9:06 A.M. The next meeting will be held on November 10, 2025 at 9:00 A.M.
